TO ORDER BY PHONE

If enrolling by phone, please call USMR between 8 a.m. and 5 p.m. Eastern Time Mon. - Fri. (except on major holidays) to arrange shipment of your USMR Business System. If you call by 2 p.m. Eastern, we normally ship your order the same day. Business Systems are sent by courier, 2nd DAY AIR. For your protection, credit card orders need the cardholder's signature. Just fax the signed credit card information to 772-225-3136.

TO ORDER BY MAIL OR FAX

If you would prefer to sign up by mail, please mail or send your signed and completed Order Form by courier (i.e., Fedex or UPS) to **US Mortgage Reduction, Inc., 1282 NE Business Park Place, Jensen Beach, FL 34957-5319**. Orders paid by certified funds or credit card are normally shipped the day received. If you prefer, you may send a personal or business check. After our check processing period (usually 10 business days), your order will be shipped. We reserve the right to *guarantee* any check. If check processing difficulties occur, a credit verification may apply. **If you wish to order by fax**, simply fax your **signed and completed** order blank, including credit card information, to us at 772-225-3136.

C.O.D. SHIPMENTS

If you request your order to be sent C.O.D. ("Cash On Delivery"), an \$8.50 charge will be added. Also, for C.O.D. orders, please fax us (prior to shipment) a copy of the certified bank draft, cashier's check, or money order that you will be giving to the delivery agent. Otherwise, all shipping costs must be prepaid by a credit card. **(All C.O.D. shipments will need to be paid to the carrier by certified funds.)**

TO COMPLETE THE FORM, PLEASE FOLLOW THESE SIMPLE STEPS

- 1) **MAILING/SHIPPING ADDRESS:** Complete the boxes provided. If your U.S. SHIP TO address differs from your mailing address, please complete the **SHIP TO** box, otherwise print "SAME AS MAILING." A physical street address is required for courier delivery. We are unable to ship to a P.O. Box or to a temporary address. **(Please note, if you are paying by credit card, orders can only be shipped to the card's billing address.)**
- 2) **TOTAL** column: add the item price plus the item ship cost and multiply by the Quantity desired. Enter the total amount on the line next to each item you are ordering.
- 3) **SUBTOTAL** box: Add all amounts entered in the TOTAL column and enter the sum in the box provided. Be sure to include the Supply Total shown above in the Subtotal Box on Page 1 of the order form.
- 4) **SALES TAX:** If your order is shipping to Florida, calculate the appropriate sales tax for your area and enter it in the box.
- 5) **EXTRA SHIPPING CHARGES:**
 - A. If your order is shipping to Alaska, Hawaii, or Puerto Rico, please add \$14.00 to cover the extra courier fees.
 - B. If your order is shipping to the U.S. Virgin Islands, please add \$14.00. These orders will be shipped via U.S. Insured Mail (no C.O.D.s).
- 6) **TOTAL AMOUNT DUE** box: Add SUBTOTAL and any applicable SALES TAX or EXTRA SHIPPING CHARGES. Enter the total in the TOTAL AMOUNT DUE box.
